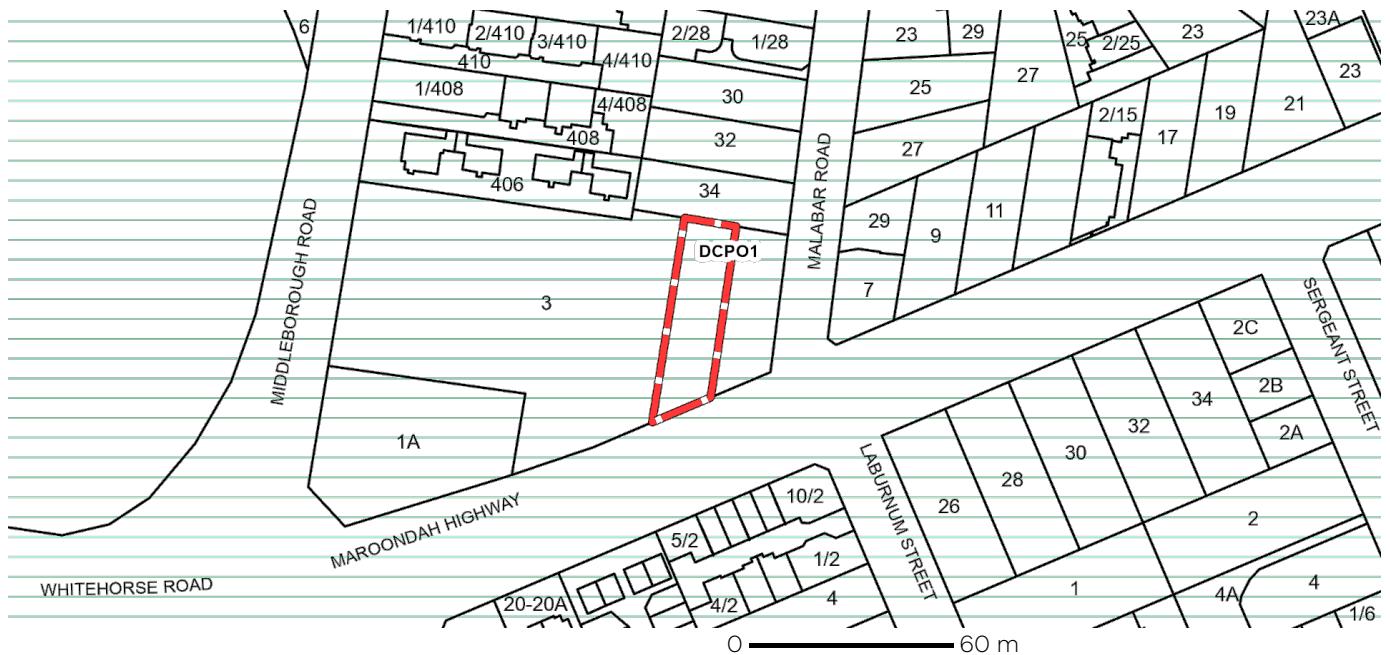

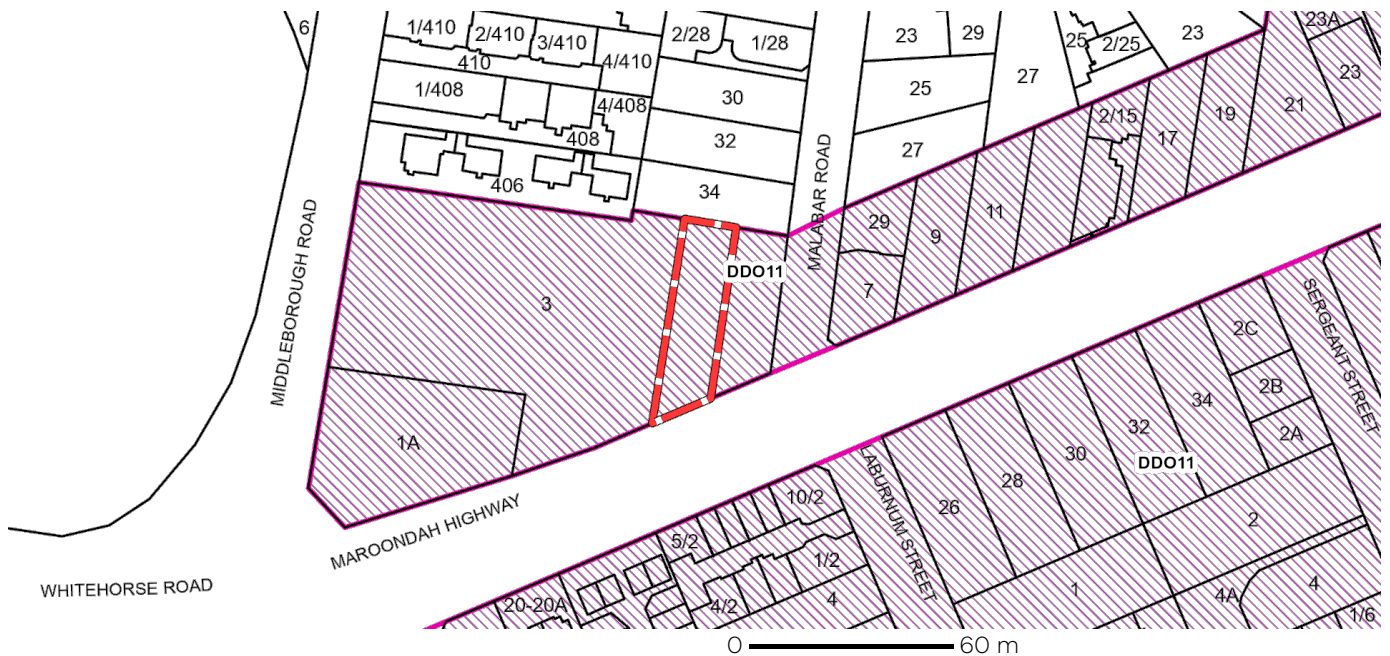

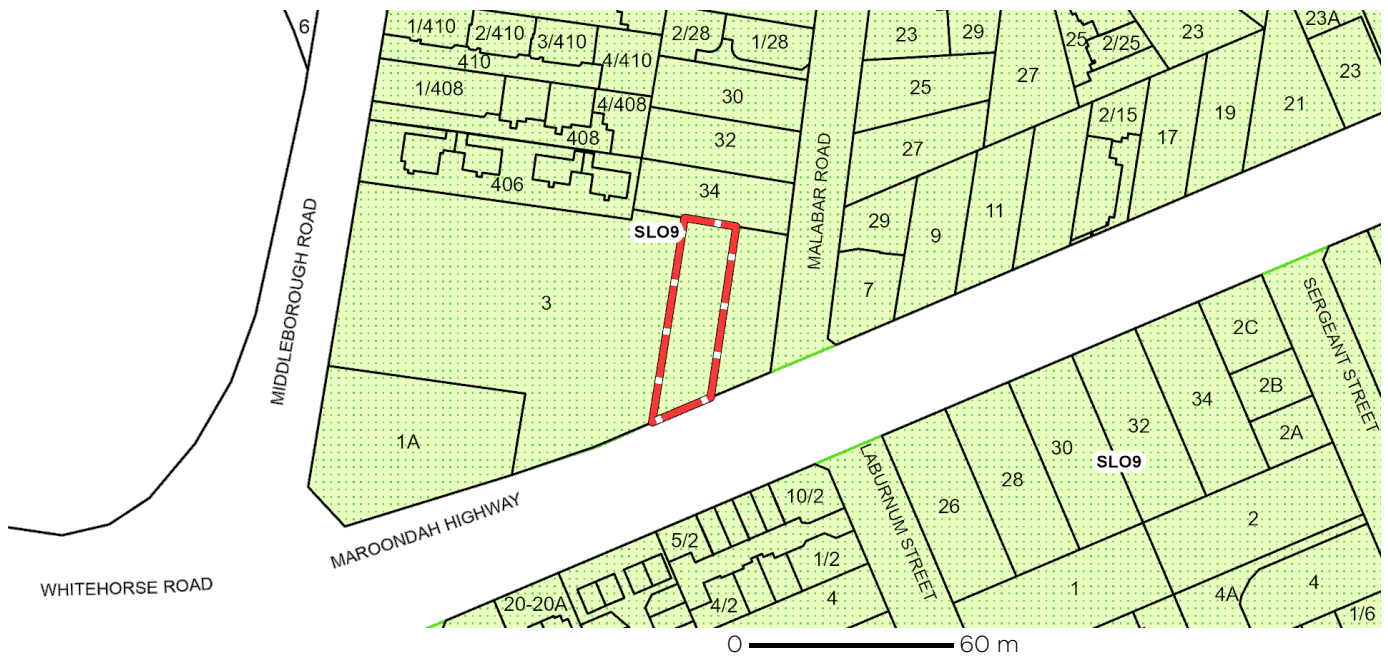

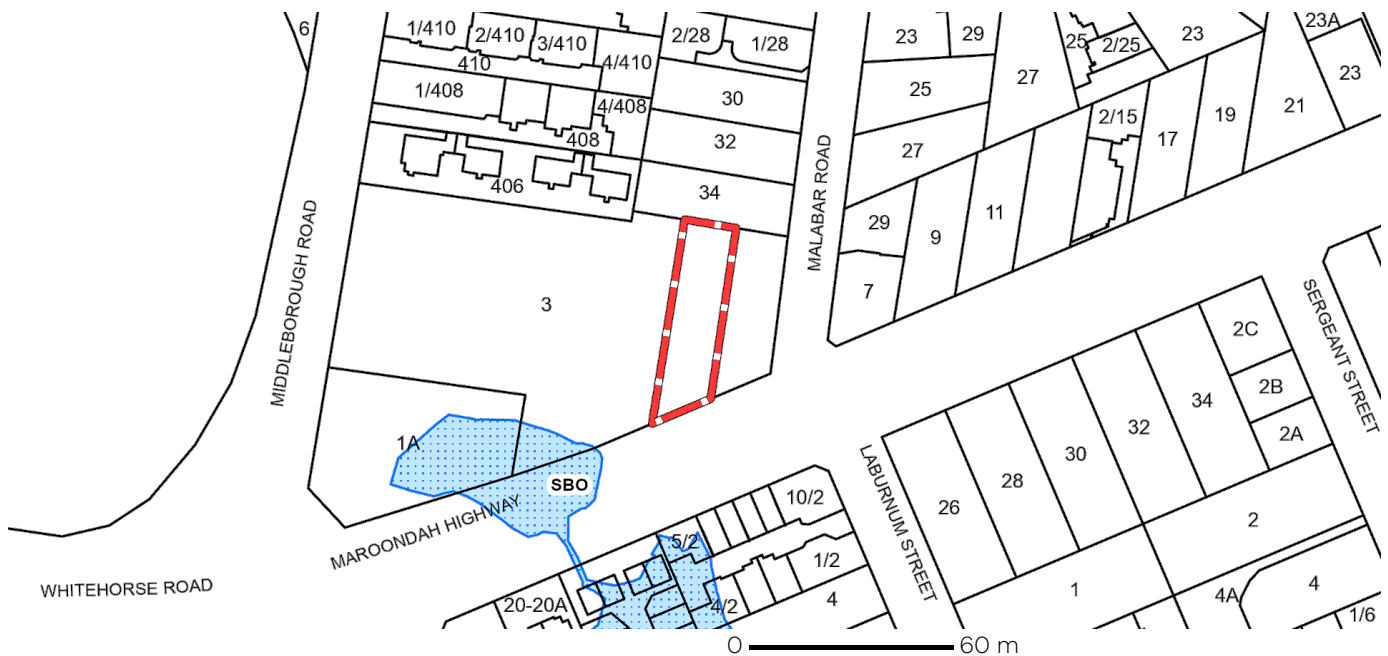

Designated Bushfire Prone Areas
