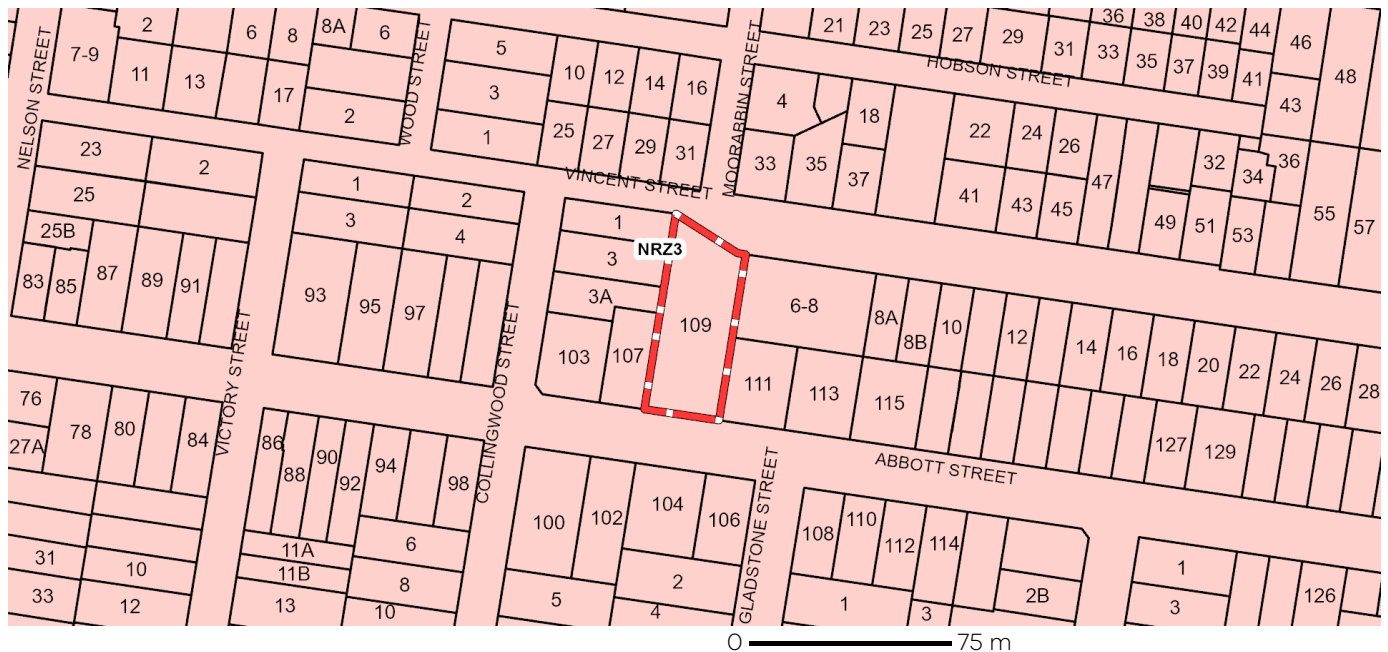

Designated Bushfire Prone Areas

This parcel is not in a designated bushfire prone area.
