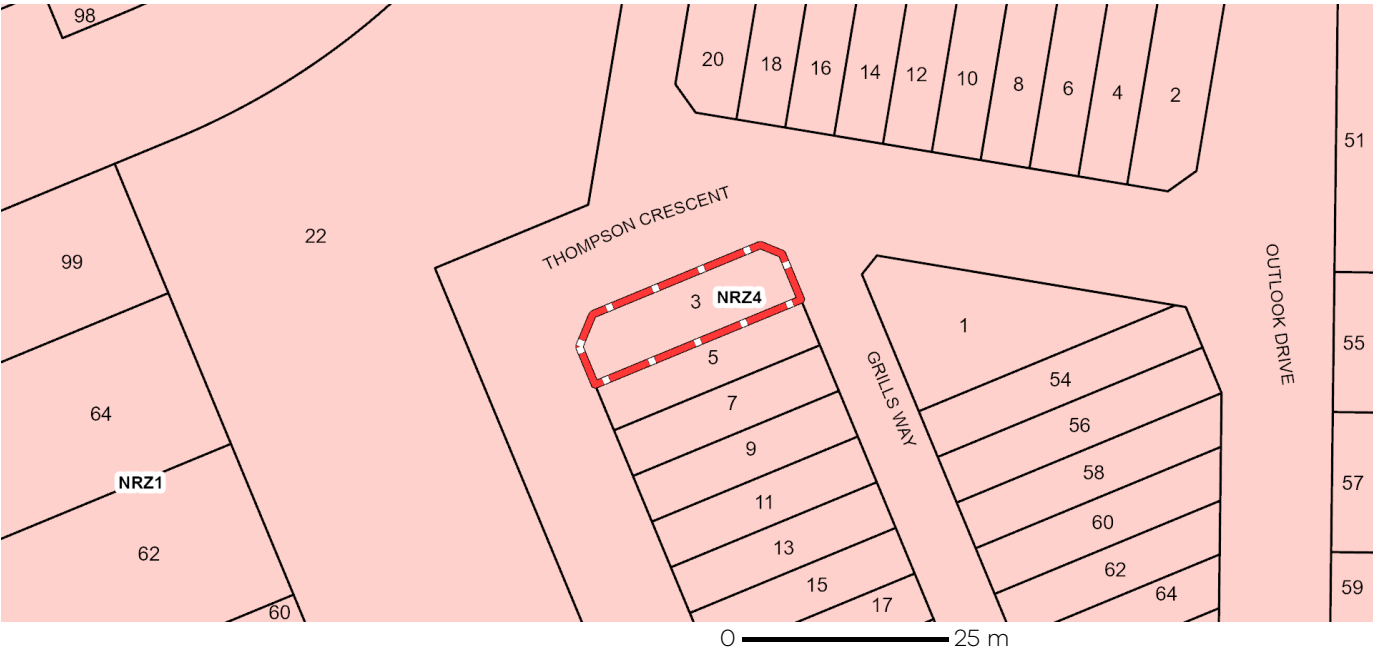

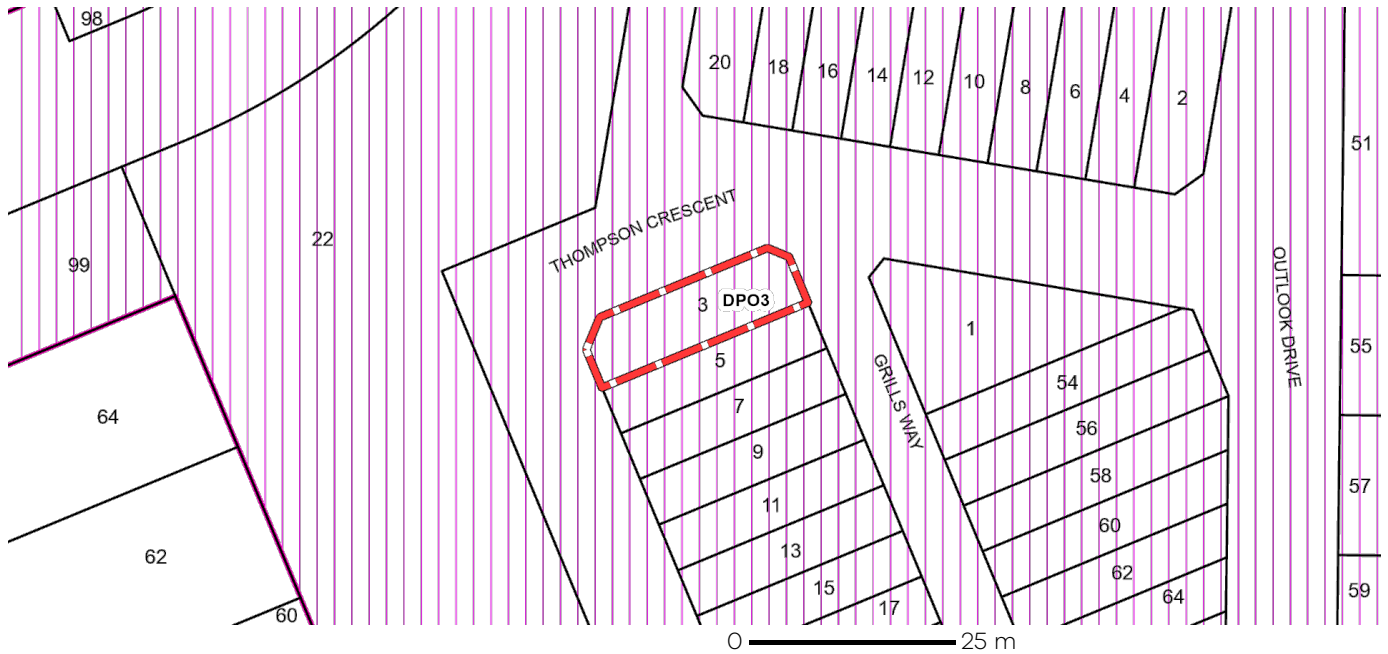

Designated Bushfire Prone Areas
