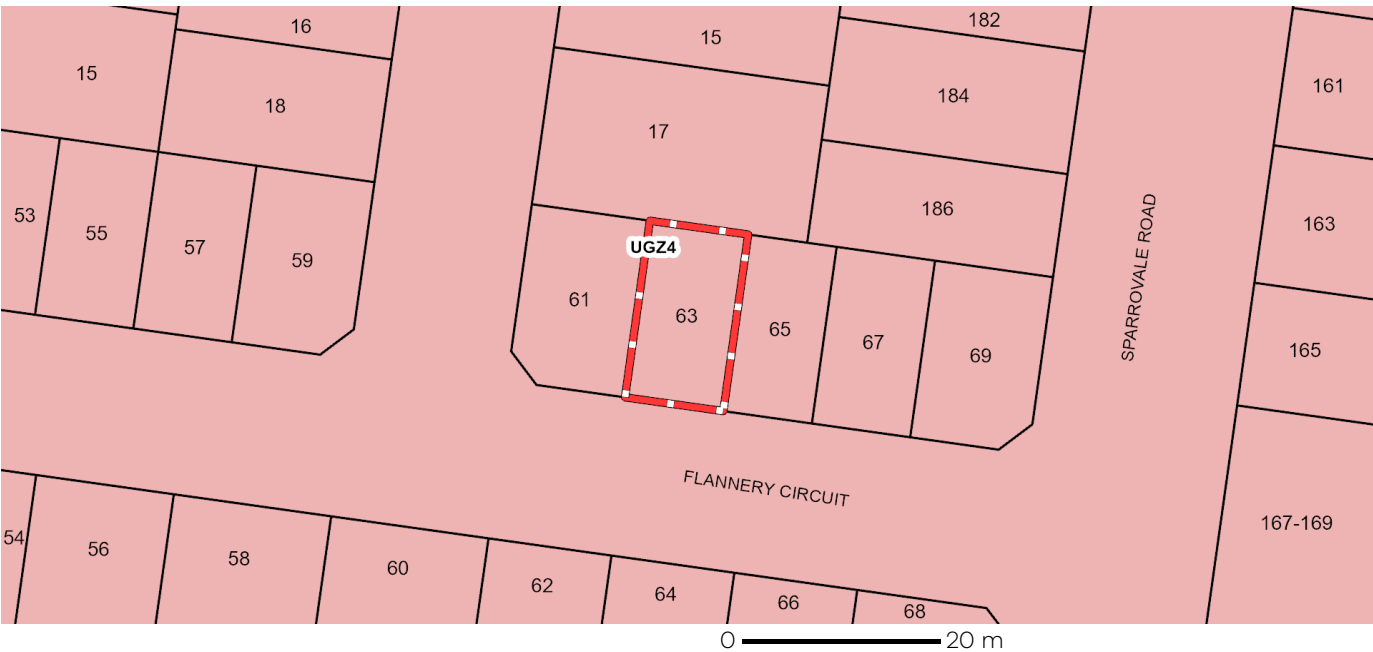

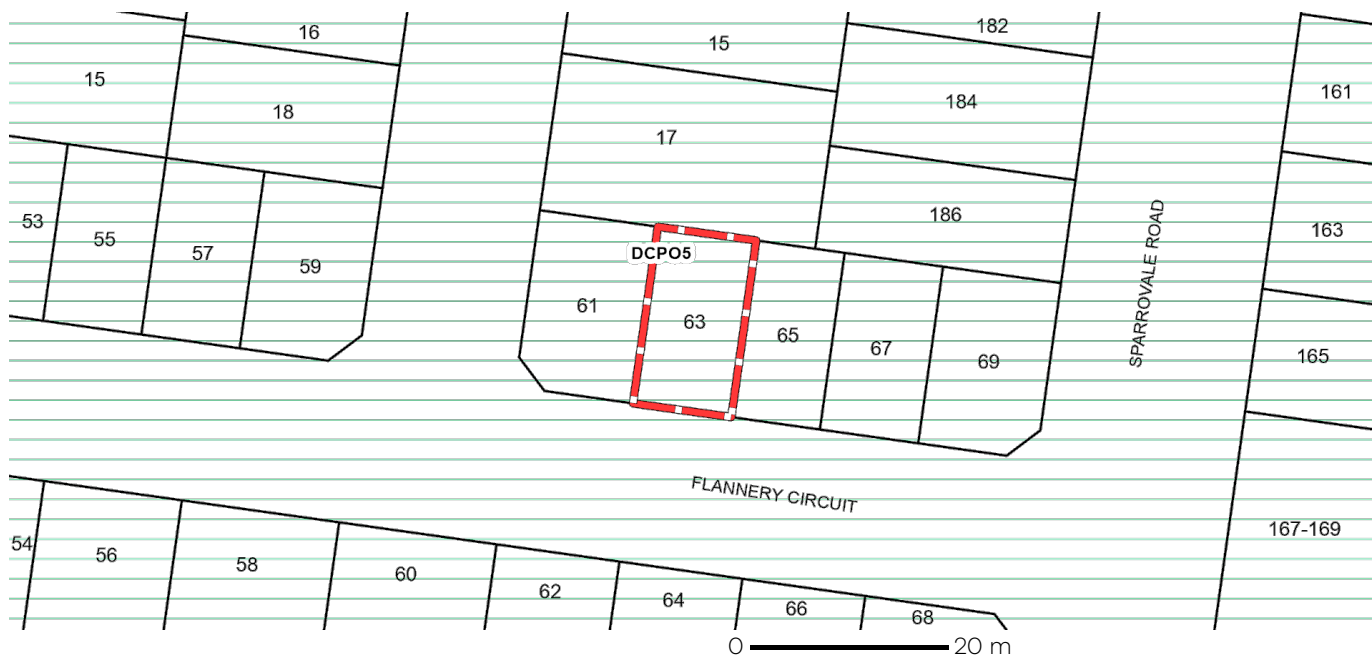
UGZ - Urban Growth

Designated Bushfire Prone Areas
