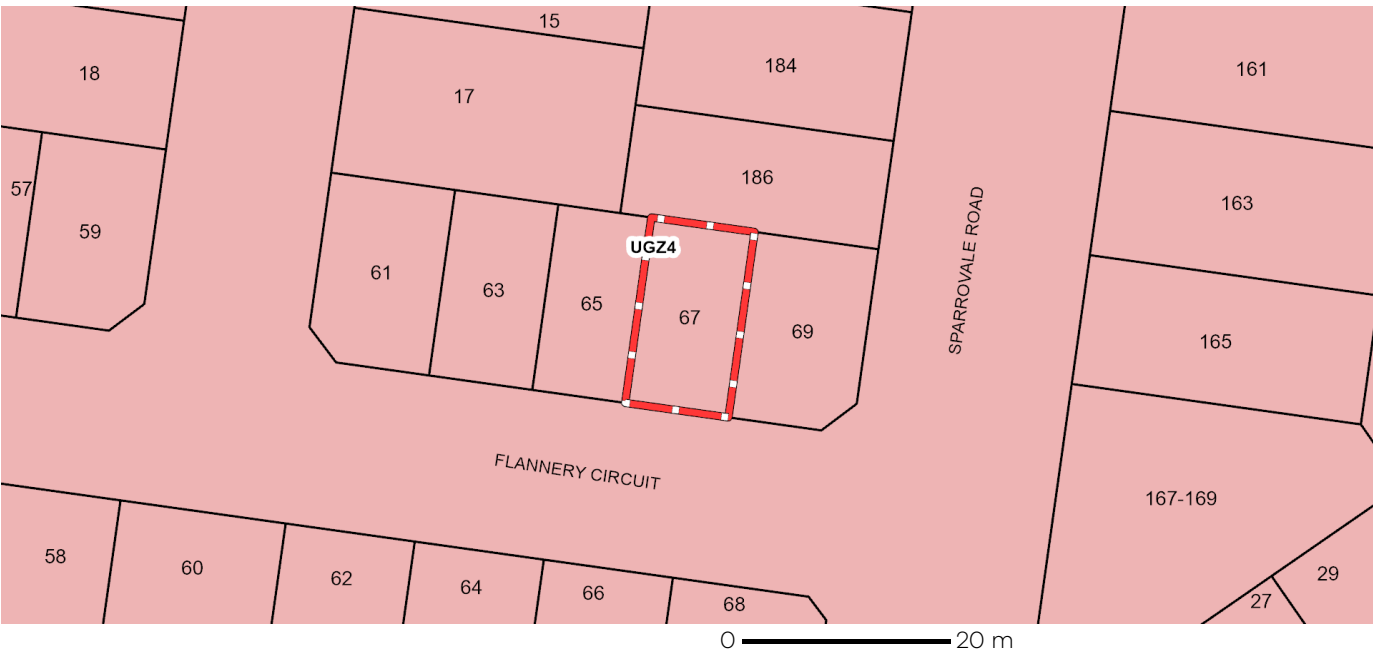

Designated Bushfire Prone Areas
